

Title: Modified exponential smoothers for time series forecasting

Abstract: We consider the problem of prediction of stationary and nonstationary univariate time series using a modified exponentially weighted moving average method. We also extend this method for prediction of time series regression where there are multiple covariate series. Theoretical justifications as well as numerical examples for our method are provided.
